- LIABILITY/INSURANCE: All property brought on the premises or left in the space shall be at the user's sole risk and the owner of Didsbury Mini Storage Ltd. and any representatives are in no way liable for loss, injury or damage to such property or for personal injury derived from any case. Please contact your insurance company for coverage.
- 4. LOCK: The user shall keep the space locked and secure at all times with no more than one padlock. Gate codes are personally assigned and the user agrees to not share that code except with those requiring access to the specific unit.
